

Travelling Athlete Agreement

and

Snowboard Yukon

Travelling outside of the Yukon to pursue your goals in snowboarding should be an exciting and enriching experience. In order to optimize your experience and in recognition of the financial and time investment made by Snowboard Yukon, the coaches and your personal support team (e.g. parents/guardians) who support you, you are being asked to sign and abide by this agreement.

I agree to:

1. Individualized Training and Competition Standards:

- a. Do my best throughout the trip.
- b. Attend all training sessions and competitions from start to finish.
- c. Follow coaches directions and decisions.
- d. Behave in an appropriate manner during and after camps and comps.
- e. Learn from the trip and provide my coaches with constructive feedback about the experience.

2. Respect and Behaviour:

- a. Be respectful to coaches, team members, competitors, officials and the public at all times and possess a positive attitude.
- b. Do assigned housekeeping tasks such as cooking and cleaning to the best of my ability.
- c. Keep my accommodations and rooms clean and tidy.
- d. Respect my teammates personal space.
- e. Be helpful; offer a hand to the staff and your teammates, if you see something that needs to be done, do it without being asked.
- f. Abide by all curfews set by the coaches.
- g. No use of tobacco or alcohol by minors what so ever.
- h. No use of tobacco or alcohol by those of age (as determined by the laws of the location of the trip) in the accommodations or during training sessions.
- i. No tolerance for drug use what so ever.

3. Injuries:

- a. Report all injuries immediately to the coaches.
- b. Refrain from snowboarding if requested by a coach, official or medical professional.

- c. Refrain from snowboarding in the event of sustaining a concussion and provide clearance from a doctor to return to play.
- d. Obtain sufficient health and travel insurance and insure it covers all my needs outside of the Territory.

4. Official Policies (available at www.snowboard yukon.com/documents):

- a. Follow the Canada~Snowboard Code of Conduct
- b. Adhere to the Canada~Snowboard Anti-Doping Policy
- c. Be subject to the Snowboard Yukon Discipline Policy

If I fail to comply with the above I am aware of the following:

Procedures for Discipline

On the trip (including travel to and from) the coaches are responsible for discipline of all infractions. Infractions will be deemed minor or major by the coaches who will then take the required actions as outlined by Snowboard Yukon policies.

1. Minor infractions:

In determining discipline, the coaches will give all involved individuals an opportunity to respond to allegations in private. All infractions will be recorded in writing and filed confidentially unless further steps are required by the Snowboard Yukon Discipline Policy.

Disciplinary Actions during the trip may include but are not limited to:

- *removal from the current activity*
- *verbal or written apology*
- *removal from competition*
- *constant coach supervision*
- *earlier curfew*
- *being sent home (at the expense of the athlete)*

2. Major infractions:

The consequences of major infractions extend beyond the trip and will follow the procedure outlined in the Snowboard Yukon Discipline Policy.
